FlexPen[®] is an easy-to-use disposable device that is used by millions of people with diabetes worldwide.^{1,4}



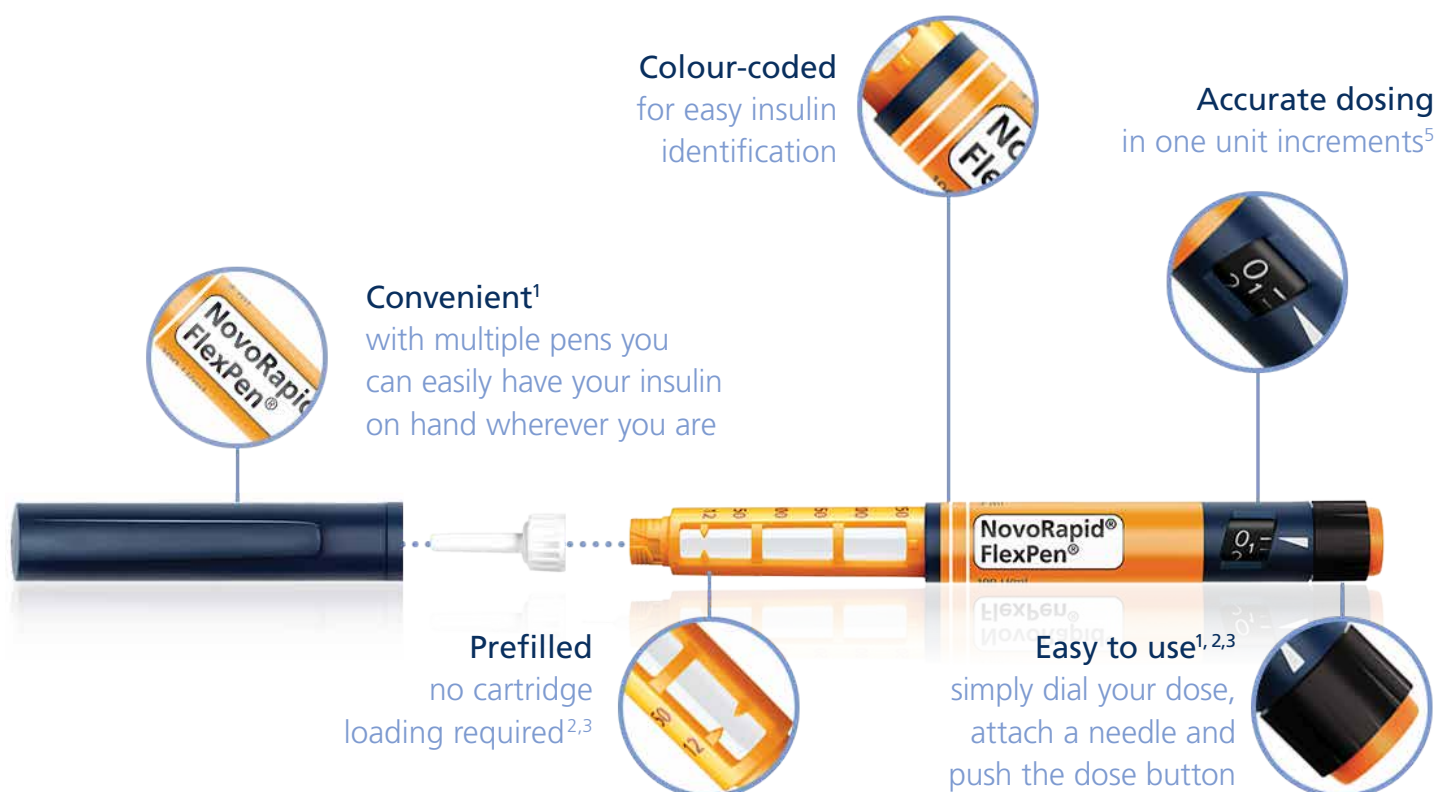
